### RULES AND REGULATIONS

#### YOUTH SHALL REFRAIN FROM:

1. Consumption, possession, and / or being in the presence of any alcoholic beverages or illegal chemical substances.
2. Possession and / or use of any tobacco products.
3. Use of language found to be objectionable by other youth or chaperones.

#### YOUTH ARE EXPECTED TO:

1. Have an exhibit in this building. However, a youth may stay in a building that does not house the project the youth is enrolled in if the youth has a chaperone sign his/her permit and the superintendent approves the youth.
2. There **must** be a chaperone for every five to six youth and there must **always** be a **minimum of two chaperones** in the barn.
3. Youth shall be responsible for finding chaperones for themselves.
4. Understand that the parent / chaperone in charge (over 25 years of age) is dedicated to helping the exhibitor have an enjoyable and educational experience. **Youth not cooperating will be sent home.**
5. Understand that the parent / chaperone in charge has complete authority over all exhibitors staying in this building. **No other sleeping locations will be allowed, because of liability.**  
**NO PERMISSION TO LEAVE WILL BE GIVEN BETWEEN 12 MIDNIGHT AND 6 A.M.**
6. Understand that the number of exhibitors granted permission to stay is the decision of the Superintendent.
7. Have read and understand any additional directions posted by the Superintendent of each building.

#### ALL PARTIES INVOLVED AGREE:

1. In case of an accident, qualified emergency care personnel will be called.
2. The parent / chaperon cannot be liable for circumstances beyond their control.
