PARTICIPATION / SAFETY

The International Demolition Derby is promoted as an unusual spectator attraction. In the interest of safety, Drivers and Mechanics are subject to, and must obey, the following rules and regulations which are set up by the promoter and the track where this event is being held.

- A. Each required driver must fill out an entry blank. All drivers must supply their own cars, only one entry per person per class.
- B. All drivers 17 or younger years of age must have a notarized release signed by his or her parents or guardian.
- C. The track or promoter reserves the right to approve or reject all entries.
- D. Everyone must sign the release sheet and receive a pit pass to be permitted in the pit area or on the track.
- E. No drinking alcoholic beverages on track, emergency vehicle area or in the pit area. Any driver or pit person under the influence of alcohol or drugs will be immediately disqualified and removed from the grounds.
- F. Any driver or crew member disobeying the rules will cause his or her car to be disqualified. Unsportsmanlike conduct will not be tolerated and will be grounds for disqualification and barring from future derbies. Drivers are responsible for the actions of their crew members.
- G. International Demolition Derby will not be responsible for any damage caused by driver's negligence on the track or in the pit area.
- H. The promoter, track owner or fair association will not be held responsible for any cars, parts, or personal property before, during and after the show or overnight.
- Car and driver must sign in at registration desk at least ONE HOUR PRIOR TO EARLIEST SHOW TIME.
- J. Safety belt, DOT approved helmet, goggles, safety glasses or face shields are required.
- K. No one rides outside of cars anytime due to insurance regulations.
- L. No deliberate hitting of driver's door.
- M. Vehicles must always have dependable brakes and track boundaries must be observed.
- N. A vehicle will be disqualified if the driver's door comes open during the heat.
- 0. One minute limit is enforced by the track officials for re-starts and making competitive contact with another car. Hits must be aggressive.
- P. A \$100.00 protest fee is required to contest another car. Protest must be made PRIOR to running of event.
- Q. Track boundaries must be always observed. Any car shoved or driven out of bounds may be immediately disqualified if Derby officials feel it's a safety hazard.
- R. Towing and transporting Demolition Derby cars to and from race locations must meet highway safety codes.

TYPE OF CAR

Mini Truck/Van/SUV may be rear or front wheel drive. Gas Only!! No Diesel Trucks!! The only all-wheel drive vehicles allowed are those that become immobile if one wheel is lost. Call to check on approval).

PREPARATION OF CAR

(Remove the following before arriving at fairgrounds or track.)

GLASS/INTERIOR: All glass including windshield, side windows, rear window, head, and taillights must be removed. Other interior parts, i.e. door panels, headliner, rear seat etc., should be removed. Auto must be swept clean, no junk tires, wheels, metal parts, broken glass, etc. allowed in the car.

BUMPERS: Bumpers and mounts are to remain stock, bumpers may be wired/chained in 4 places. Sheet metal only!

RADIATOR: Radiators must remain in original position or taken off. Comparable replacement radiators are permitted. Transmission coolers are permitted, with official approval.

ENGINE/TRANSMISSION: Motor/ Transmission must be stock to the car!! No mount changes.

BATTERY: One or two batteries may be used. If the battery is moved from the original position, it must be placed on floorboard of driver's compartment and securely fastened and covered.

HOOD: Hood may be bolted or wired in 6 places. It is mandatory that an opening be cut in hood, square or circular. Hood may be bolted or wired in 6 places.

CAGES: 4-point floating cage only!! All cages must be securely welded/bolted to sheet metal only. No frame attachments. Cages must stop at door post/support.

DOOR/WINDOW: It is mandatory that a chain, strong wire or strap be secured from the center of roof to dash for a center post to stop hood from coming through front window. All doors must be fastened shut by wire, straps, or chains. Drivers' door only may be welded solid. No more than wire may be used on rear window opening from sheet metal to sheet metal. (Not to trunk lid)

FRONT SUSPENSION: Front suspension must have movement (NO EXCEPTIONS).

TIRES: Stock D.O.T tires only.

CAR NUMBER: Car numbers must be large and bright in color and located on both front doors and the roof of the vehicle.

GAS TANK: Stock gas tanks must be removed from their original position and placed inside the car in front of rear axle and no farther forward than the rear of the front seat; all tanks must be securely fastened to floor and covered; although a portable tank is recommended, you may also use the original tank and fuel pump. Gas lines and fittings to fuel tanks must be secured and leak proof. Only metal or rubber gas lines permitted.! Electric fuel pumps permitted but must have a shut off switch within driver's reach. Inspection officials will give final approval on tanks and fittings.

REMEMBER THIS IS A STOCK CLASS. IF IT DOESN'T SAY YOU CAN DO IT THAT MEANS YOU CAN'T.
