- A. All exhibits will be judged face-to-face, Monday of Fair, from noon to 7 p.m. with a break at 3:30 p.m. The Youth Building will be open at 11:00 a.m. Numbers will be available at 11:45 a.m. After judging is finished, the building will close. Judging will take place in the 4-H Youth Building.
- B. A maximum of five (5) different entries per exhibitor may be exhibited per division, but not more than one exhibit per class number.
- C. All posters and collages should be 14" x 22" in size.
- D. Displays should be more detailed in explanation than a poster. They must be 3-dimensional and include articles to assist in explanation.
- E. Any item intended for hanging should have 2 holes punched near the top or other applicable hanger affixed to the back.

 - d. Report, Essay, or Computer Document about an older relative or community member that you interviewed
 - e. Any other entry pertaining to History or Heritage Project Work

Division 5 – Citizenship

- A. Examples include but are not limited to:
- Poster listing your group's ground rules

 - Scrapbook or Poster displaying any media coverage your project received including Newspaper Articles, TV and/or Radio Coverage, or other media coverage
 - Scrapbook or Notebook describing what your group has done and learned from your Citizenship Project
 - Scrapbook detailing your entire Citizenship Project from start to finish
 - Samples of Letters written to support your Citizenship Project
 - Typed Transcript of Public Speech written to support your Citizenship Project
 - Personal Journal reflecting what you learned during the Citizenship Project
 - Any Other Communication item created by you to support your group's Citizenship Project
 - Poster illustrating or promoting a 4-H Community Service Project
