



# PHOTOGRAPHY EXHIBITION FAIR NIGHT PHOTO SHOOT

Thursday of Fair Week

Entry Form must be Postmarked on or before July 15



**Who:** Anyone ages 14 and up. Pre-registration is required. Mail your entry form EARLY (no online entry) as space is limited to the first 30 exhibitors. The first 30 entrants will have confirmation of their chance to compete in the Fair Night Photo Shoot via e-mail. Ages 14-17 must have parent or guardian permission signature.

**Limit:** 1 Photo per Exhibitor

**Where:** Check-in will be in the Open Class Photography Building no later than 6:30 p.m.

**What:** Pre-registered exhibitors will bring their digital cameras to the Fair with one (1) blank memory card. No RAW format will be allowed. The theme of the photo shoot will be announced and instructions given. After the period of the photo shoot (1 Hour), participants will return to the Open Class Photography Building and download one (1) image to be submitted for judging from their camera memory card. **NO DIGITAL ALTERATIONS or CROPPING!**

**\*NO MONOPODS OR TRIPODS will be allowed. Tripods can pose a trip hazard so their use in this contest will not be permitted\***

**Judging:** 8:00 – 8:30 p.m. or after all entries are printed. Participants and guest judges will vote for their favorite. In case of a tie, guest judges will make the final decision.
